Our signature fundraising event held each fall, Benefits of Laughter celebrates stories of recovery from mental illness and affirms the importance of effective mental treatment for the health of our workforce, schools, and community. A unique feature of the evening is a comedy performance, proving that sometimes laughter really is the best medicine.

Format

Typically, the evening includes a cocktail reception, dinner, program, and comedy performance. Guests have an opportunity to network, learn about Skyland Trail, hear from a program graduate, and enjoy an evening of laughs.

Attendance

Annually the event is attended by more than 600 of Atlanta's corporate, philanthropic and community leaders. Corporate sponsors and individual patrons serve as table hosts and may invite guests to attend the event.







Impact

Annually the event raises more than \$1 million through corporate and individual contributions. Proceeds support financial aid awards that improve access to treatment and important therapeutic programs for adults and teens.

Who We Treat

- adults ages 18 and older with a primary mood, anxiety, or thought disorder, including bipolar disorders, major depression, and schizophrenia. Many clients have co-occurring substance use, borderline personality disorder, or trauma-related disorders.
- adolescents ages 14 to 17 with depression, bipolar disorder, anxiety disorders or trauma-related disorders.

Expert Psychiatric Care with a Holistic Approach to Wellness

Clients receive individualized, evidence-based care from a multidisciplinary team of experts based on their diagnoses, symptoms and self-defined goals.

Our integrated medical, mental, and social model includes a wide variety of therapies and services. A structured but diverse daily schedule helps clients develop strategies to improve mental health, physical wellness, independence, relationships with family and friends, and school or career readiness.
